

RESOLUTION R-00-290

A RESOLUTION OF THE MANATEE COUNTY CIVIC CENTER AUTHORITY AMENDING EXHIBIT C TO RESOLUTION R-00-86 TO PROVIDE ADDITIONS TO THE PRICING SCHEDULE FOR THE CIVIC CENTER AUTHORITY FACILITIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Manatee County Ordinance No. 91-71 and Resolution No. R-00-86 of the Manatee County Civic Center Authority, a Manual of Policies and Rental Pricing Schedule have been adopted; and

WHEREAS, the Civic Center Authority has determined that it is necessary and in the best interest of the operations of the Manatee County Civic Center Facilities to amend the policies and pricing schedule as provided herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MANATEE COUNTY CIVIC CENTER AUTHORITY AS FOLLOWS:

1. The Manatee Convention and Civic Center Pricing Schedule provided in Exhibit C to Resolution R-00-86 shall be amended to provide the following additional prices under Section A.2.:

Anna Maria North	-	\$100.00
Anna Maria South	-	\$125.00
Anna Maria	-	\$175.00

2. The Manatee Convention and Civic Center Pricing Schedule provided in Exhibit C to Resolution R-00-86 shall be amended to provide the following new subsection J:

J. Promoter Incentive Package

The Director or the Director's Designee shall have the discretion to provide any or all of the following at no charge as an incentive to promoters renting the Center Hall for one move in day and two consecutive event days:

Six (6) - 8' Tables with skirts; 12 chairs; three 3 - 20 amp outlets; six (6) easels (based on availability); one (1) wireless microphone; one (1) forklift with driver for two hours; one (1) cassette player with radio. Up to five (5) gallons of coffee may also be provided for the move in day, and Utility Charge Discount for move in day of \$125.00 for up to eight (8) hours may also be provided.

3. The Crosley Museum Rental and Pricing Schedule provided in Exhibit C to Resolution R-00-86 shall be amended to add the following new subsection H:

H. Pricing Policies - Where appropriate, all pricing policies provided in the Manatee Convention and Civic Center Rental and Pricing Schedule shall apply to the Rental and Pricing Schedule for the Crosley Museum.

4. This Resolution shall take effect upon adoption.
