Manatee County Clerk’s Office Monitoring Coronavirus

The Manatee County Clerk of the Circuit Court & Comptroller is monitoring the rapidly evolving Coronavirus/Covid-19 situation. Clerk Angel Colonnese is meeting with her Executive Team regularly to discuss updates and plans, if a health situation in the office should occur. At this time, the office remains open to the public and is operating during normal business hours. “If a Coronavirus health situation arises in our office, we have discussed the possibility of some employees working from home, so that we can continue to serve our community,” said Clerk Angel Colonnese. “However, we do not have any cases or cause for concern at this time. If we do, we will address the matter immediately and take action. We are being very proactive about this situation and I’m meeting with my Executive Team regularly, to monitor and discuss updated information.”
